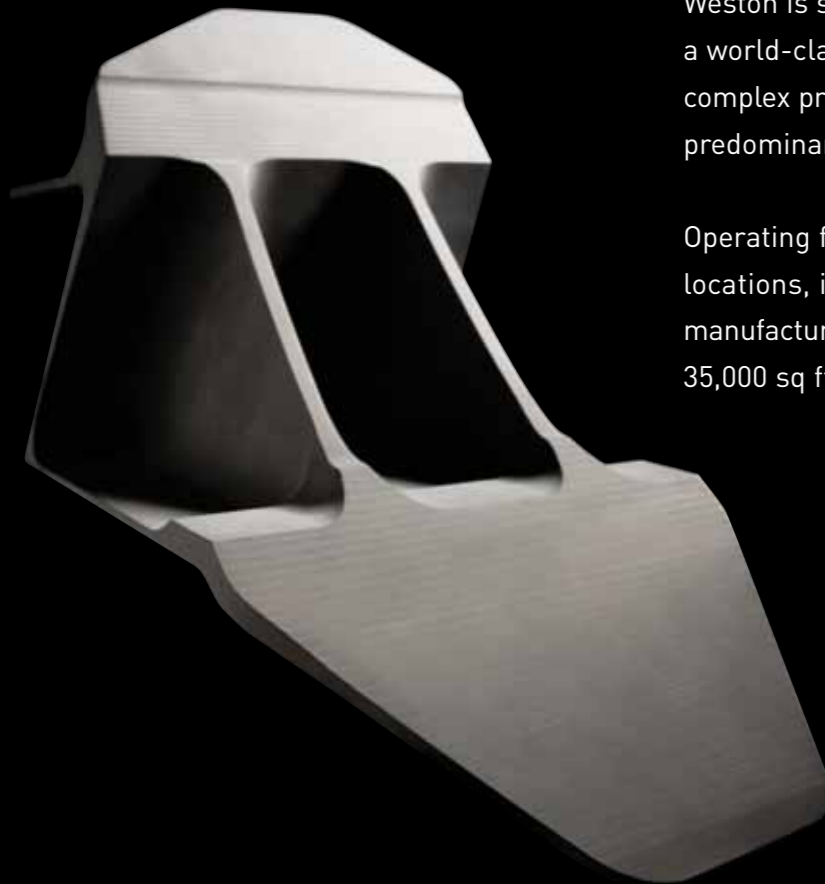

on compressor aerofoil component manufacture.

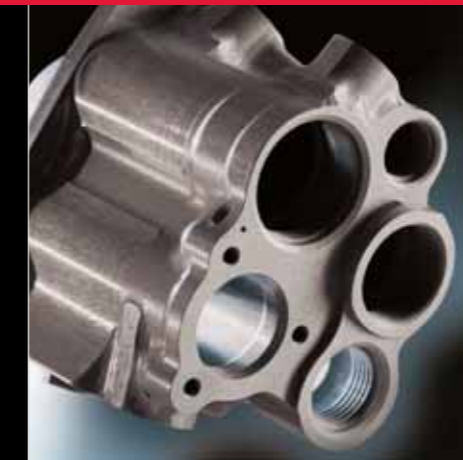
